Information for people with walking difficulties and wheelchair users

- There are 3 parking spaces for people with disabilities. These are not marked accordingly. One parking space is at least 400 cm wide and 500 cm long.
- The parking space is 50 m away from the entrance. The path is at least 400 cm wide and 50 m long. There is a longitudinal slope of max. 7% on 3 m. The surface of the path is not low vibration and easy to walk and drive on.
- The entrance/access to the building is possible without steps (max. 2 cm threshold, if necessary via a ramp). Access to room 1 also step-free. In the restaurant several steps without handrail.
- Doors are at least 69 cm wide (door to bathroom).
- Passages in rooms (dining room, bedroom, checkout counter, etc.) are at least 90 cm wide.
- There are 4 accessible tables (maximum height 80 cm, accessible at a height of 67 cm with a depth of 30 cm).
- Assistance dogs are not allowed.

Bedroom - room 1

- The room is a double room.
- The movement areas are:
- in front of essential furnishings (e.g. cupboards) 90 cm x 200 cm;
- to the left of the bed 170 cm x 120 cm;
- to the right of the bed 90 cm x 360 cm.
- The bed is 45 cm high.

Bathroom

- The movement areas in the bathroom are:
- in front of the sink 85 cm x 130 cm;
- in front of the WC 110 cm x 57 cm;
- to the left of the WC 112 cm x 47 cm;
- to the right of the WC 18 cm x 43 cm.
- There are no grab bars at the toilet.
- The washbasin is not accessible from underneath.
- The mirror can be seen while sitting or standing.
- The shower has a step of 25 cm and is 80 cm x 80 cm.

Information for people with hearing impairments and deaf people

We have compiled some **information on accessibility** below. You will find detailed information in the test report.

- There is no alarm.
- There are 4 tables with bright and glare-free lighting with no lamps standing or hanging that interfere with the field of vision or eye contact.
- There are 2 tables with low ambient noise.
- There is at least one freely available electrical outlet near the bed.
- There is no inductive hearing system available at the reception or in the meeting room.
- W-LAN is offered.

Information for visually impaired and blind people

We have compiled some **information on accessibility** below. Detailed information can be found in the test report.

- The entrance area is visually contrasting to the surroundings.
- There are no glass doors.
- There are no obstacles (e.g. objects protruding into rooms or corridors).
- The operating elements (e.g., door handles, light switches, emergency call buttons) are tactilely detectable almost everywhere and are partially visually contrasting.
- Walls or other structural elements can be used for orientation almost everywhere.
- The walkways in corridors/paths/corridors are visually contrasting to the surroundings almost everywhere.
- All elevated areas that can be used by guests (entrance area, cashier/counter, sleeping rooms, hallways, corridors) are well lit, i.e., bright and glare-free.
- No assistance dogs are allowed.

Information for guests with cognitive impairments

- The name or logo of the company/facility is clearly recognizable from the outside.
- The destination of the route is within sight or route signs are at a constantly visible distance or there is an uninterrupted route guidance system.
- A business card with the hotel's address and telephone number is visibly displayed at the front desk or in the dormitory.
- No assistance dogs are allowed.

Information for allergy sufferers and people with food intolerances

House dust

- Short pile carpet in accessible areas that is vacuumed daily. Smooth floor in accessible areas that is damp mopped daily.
- Allergen-impermeable protective covers (encasings) available for mattresses, comforters and pillows.
- Allergy-safe comforters and pillows without down available.

Food intolerances

- Some of the controls (e.g., door handles, light switches, emergency call buttons) are visually contrasting.
- The walkways in corridors/walkways/corridors are visually contrasting to the surroundings almost everywhere.
- All elevated areas that can be used by guests (entrance area, cashier/counter, bedrooms, corridors, hallways) are well lit, i.e., bright and glare-free.
- The destination of the route is within sight or route signs are at a constantly visible distance or there is an uninterrupted route guidance system.
