For children there's a wonderful playground for romping, for parents rest islands with deckchairs under trees.

- Living room with open kitchen, bedroom, bathroom with shower cubicle 17 cm high without grab rails
- Sauna entrance level with relaxation room, fireplace, exercise bike and floor-level shower
- Playground in the garden

Information for people with walking difficulties and wheelchair users

We have compiled some **information on accessibility** below. Detailed information can be found in the test report.

- General parking available - distance to entrance about 15 m, one step on the path. The path is not low vibration from the surface condition and easy to walk and drive on.
- Access to the apartment via a staircase with 14 steps and a handrail on one side and a step at the entrance door (12 cm). In the vacation apartment all rooms are accessible without steps.
- Doors are at least 60 cm wide.
- Passages in rooms are at least 52 cm wide (narrowest passage in the bedroom), otherwise from 100 cm.
- The play area is not accessible by wheelchair. There is no play equipment that is accessible and usable by wheelchairs.
- The (dining) table is a maximum of 80 cm high and can be moved under at a height of 67 cm with a depth of 30 cm. The sideboard, sink and stove are not accessible. The movement area in front of the kitchen unit is 250 cm x 100 cm.
- Assistance dogs are not allowed.

Bedroom

- The movement areas are
- in front of essential furnishings (e.g. cupboards) 250 cm x 109 cm;
- to the left of the bed 63 cm x 204 cm;
- to the right of the bed 52 cm x 204 cm.
- The bed is 43 cm high.

Bathroom

- The movement areas in the bathroom are:
- in front of the sink 110 cm x 180 cm;
- in front of the WC 135 cm x 165 cm;
- to the left of the WC 40 cm x 50 cm;
- to the right of the WC 30 cm x 50 cm.
- No grab bars at the toilet.
- The sink is not accessible.
- The shower is accessible via a step of 17 cm and measures 90 cm x 73 cm. No shower seat or grab bars available.

Information for people with hearing impairments and deaf people

We have compiled some **information on accessibility** below. Detailed information can be found in the test report.

- There is no alarm.
- Ringing or knocking on the room door is not indicated by a flashing signal that can be perceived in all rooms.

Information for visually impaired and blind people

We have compiled some **information on accessibility** below. Detailed information can be found in the test report.

- The entrance area is visually contrasting to the surroundings. It is not recognizable by a tactilely perceptible change of floor covering.
- There are partially glass doors; these do not have safety markings at a height of 40-70 cm and 120-160 cm.
- There are no obstacles (e.g. objects protruding into rooms or corridors).
- There is a staircase with 14 steps. The stairs have a handrail on one side. There is a tactile, but no visual, contrast between the flooring and the stair risers or risers.
- Walls or other structural elements can be used almost anywhere for orientation.
- The walkways in corridors/walkways/corridors are visually contrasted with the surroundings almost everywhere.
- All raised areas that can be used by guests (entrance area, checkout/counter, sleeping rooms, hallways, corridors) are well lit, i.e., bright and glare-free.
- Assistance dogs (companion dogs, guide dogs for the blind, etc.) are not allowed.

Information for guests with cognitive impairments

- The name or logo of the establishment/facility is clearly recognizable from the outside.

- A business card with the address and telephone number of the hotel/holiday apartment is visibly displayed in the bedroom.
- Assistance dogs (companion dogs, guide dogs for the blind, etc.) are not allowed.

Information for allergy sufferers and people with food intolerances

Animal hair

- No animals on the premises or in the immediate vicinity.
- Bringing animals is prohibited.

Pollen

- The name or logo of the establishment/facility is clearly visible from the outside.
- A business card with the address and telephone number of the hotel/apartment is visibly displayed in the sleeping room.
- Possibility to store medicines in a cool place
